

**Pennsylvania Lottery's Eagles  
Fast Play Lottery Game  
Second-Chance Drawing Rules  
July 15, 2024  
[FINAL]**

1. Second-Chance Drawing: The Pennsylvania Lottery's ("Lottery") Eagles Second-Chance Drawing ("Drawing") for qualifying Fast Play lottery game tickets.

(a) Qualifying Tickets: Non-winning PA-5250 Eagles (\$5) Fast Play lottery game tickets ("Qualifying Tickets") are eligible for entry in the Drawing.

(b) Participation and entry:

(1) Entrants must have a registered lottery account in order to participate in the Drawing. To create a lottery account, visit <https://www.PAiLottery.com>. Creating a lottery account is free.

(2) A registered lottery account holder is subject to the iLottery regulations and specifically agrees to be bound by the iLottery terms and conditions located at <https://www.pailottery.com/signup/terms-and-conditions/>, as well as any related policies.

(3) To establish a lottery account, players must provide the following information:

(i) The player's name as it appears on a valid government-issued identification or tax documents;

(ii) The player's date of birth;

(iii) The entire or last four digits of the player's Social Security Number, or comparable equivalent;

(iv) The player's address;

(v) The player's telephone number;

(vi) The player's email address;

(vii) Any other information established by the Lottery to be necessary to verify the age and identity of the player.

(4) An individual may be required to provide additional information or documentation, as set forth in the iLottery terms and conditions, to establish a lottery account or register for iLottery. The information may be used for iLottery registration or to confirm information provided by that individual during the registration process.

(5) To enter the Drawing, entrants must submit the identifying information from at least one Qualifying Ticket via the Drawing's promotional web site, available at <https://www.palottery.com>, or the Lottery's official mobile application during the entry period. The identifying information from a Qualifying Ticket may be submitted only once in the Drawing. Entries will automatically be awarded at the time of successful submission of a Qualifying Ticket. No other method of submission will be accepted, and entries submitted using any other method, including entries mailed or hand-

delivered to the Pennsylvania Lottery, are not valid and will be disqualified.

(6) Each entry must be complete and the information supplied by the entrant must be accurate. Incomplete entries cannot be accepted.

(7) Only one claimant per entry is allowed.

(8) Entrants must be 18 years of age or older.

(9) Players may submit the identifying information from an unlimited number of Qualifying Tickets in the Drawing.

(10) Once an entry has been submitted it cannot be withdrawn or changed.

## 2. Drawing description:

(a) The Lottery will conduct one Eagles Second-Chance Drawing for Qualifying Tickets. All time references are Eastern Prevailing Time.

(b) All entries received after 4:59:59 a.m. August 6, 2024, through 11:59:59 p.m. September 12, 2024, will be entered into the Drawing tentatively scheduled to be held between September 13, 2024 and September 26, 2024.

(c) The entry period for the Drawing will be posted to the Lottery's publicly accessible web site at <https://www.palottery.com>.

(d) The number of entries an entrant will receive for the Drawing is determined by the purchase price of the Qualifying Ticket entered. The purchase price and corresponding number of entries for the Qualifying Ticket is as follows: PA-5250 Eagles (\$5) = five entries.

(e) Players may review prizes won and their entries for the Drawing via the Drawing's promotional web site.

3. Prizes available to be won, determination of winners, and odds of winning:

(a) The prize entitlements described below are subject to all restrictions and limitations described in section 5, or those mentioned anywhere else in these rules.

(b) Lottery will conduct one Drawing from among all the entries received during the entry period as described in section 2(b).

(1) The first through the seventh entries selected in the Drawing will be winning entries and the entrants who submitted those winning entries shall each be entitled to a prize of two Club-level game tickets with a \$30 food and beverage credit per ticket, for a to-be-determined Philadelphia Eagles home game.

(2) The eighth through the seventy-seventh entries selected in the Drawing will be winning entries and the entrants who submitted those winning entries shall each be

entitled to a prize of two Mezzanine level game tickets with a \$30 food and beverage credit per ticket, for a to-be-determined Philadelphia Eagles home game.

(c) The Lottery has elected to increase the value of the prize won in section 3(b)(1), above, to account for federal income tax withholding in the amount of \$255.18 and state income tax withholding in the amount of \$8.08.

(d) The number of winning entries to be selected for the Drawing will be posted to the Lottery's publicly accessible web site.

(e) The odds of winning in the Drawing depend upon the number of entries received for the Drawing.

(f) A computer-generated randomizer will be used to select the Drawing winners.

4. Prize claim procedures:

(a) Winners of the prizes described in 3(b)(1) and 3(b)(2), above, that are awarded in the Drawing will be contacted by email by the Pennsylvania Lottery to initiate the prize claim procedure.

(b) Winners of the prizes described in section 3(b), above, will have seven business days from the date they are notified by the Pennsylvania Lottery, pursuant to this section, to claim their prizes. In order to claim their prizes, winners must respond to the Pennsylvania Lottery's email regarding prize

claim procedures and must submit a properly completed prize claim form within seven business days from the date they are notified by the Pennsylvania Lottery. Failure to comply with the prize claim requirements as set forth herein, for any reason, shall result in the winner forfeiting their right to receive the prize. An alternate winner will be awarded the respective prize, according to Lottery procedure.

(c) Winners of the prizes described in sections 3(b) (1) and 3(b) (2), above, must accept tickets to the Philadelphia Eagles game prize described in section 3 no later than 72 hours prior to the start of the event by performing the following steps:

(1) Winners must open the link contained in the email notifying the winners that a prize is won;

(2) Winners must create or log into an existing account in the Eagles TicketMaster Account Manager; and

(3) Winners must accept the tickets available within the Eagles TicketMaster Account Manager.

(4) In the event that a ticket winner fails to properly accept the game tickets following the procedure in section 4(c), above, no alternate winner will be awarded the prize.

(d) By entering a ticket into the Drawing, the entrant agrees to be bound by these rules, the prize claim

requirements set forth herein, and expressly waives any claim against the Pennsylvania Lottery for a prize not awarded in conformance with these rules.

5. Drawing restrictions:

(a) To be eligible to participate in the Drawing, entrants must have complied with the requirements of these rules.

(b) The Lottery is not responsible for late, lost or misdirected entries not entered into the Drawing. The Lottery is not responsible for entries that are not entered into the Drawing because of incompatible internet browsers, mobile Lottery application failure or other technical issues. If an entry is selected as a winner and rejected or otherwise disqualified during or following the Drawing, the Lottery will select another entry to replace the rejected or otherwise disqualified entry in accordance with these rules and Lottery procedure. In the event that a ticket winner fails to properly accept the game tickets following the procedure in section 4(c), above, no alternate winner will be awarded the prize.

(c) If any discrepancy exists between these rules and any material describing the Drawing, these rules shall govern.

(d) Employees of the Pennsylvania Lottery, 9Rooftops Marketing, LLC (formerly known as MARC USA, LLC), MUSL, Scientific Games, LLC, MDI Entertainment, LLC, and their

subcontractors, or a spouse, child, brother, sister or parent residing as a member of the same household in the principal place of residence of any such person are not eligible to participate in the Drawing. Offer void where prohibited or restricted.

(e) The Lottery reserves the right, in its sole discretion, to cancel or suspend the Drawing and change these rules if the Drawing cannot be conducted as planned due to errors in these rules or advertising, unauthorized intervention, tampering, fraud, technical errors, viruses, worms, bugs or any other cause that, in the Lottery's sole judgment, could corrupt or impair the administration, security, fairness, integrity or proper conduct of the Drawing.

(f) All entries shall be subject to verification by the Lottery.

(g) The Lottery reserves the right, in its sole discretion, to disqualify an entrant found to be tampering with the operation of the Drawing or to be acting in violation of these rules or applicable law.

(h) The Drawing is governed by the laws of the Commonwealth of Pennsylvania. Applicable laws and regulations apply.

(i) Final determination of winners will be made by the Secretary, whose judgment will be final and binding.

(j) A prize awarded in the Drawing to a person who dies before receiving the prize shall be paid according to 61 Pa. Code § 811.16 (relating to prizes payable after death of a prize winner).

(k) A winner is responsible for all taxes arising from or in connection with any prize won.

(l) A player may only win the prize for which the player is first selected in the Drawing. Subsequent entries, from the same individual, selected in the Drawing will be disqualified and one replacement entry will be selected.

(m) Winners and guests must abide by all venue policies. Any promotional partner reserves the right to revoke full or partial prize from any winner or winner's guest whom it or venue personnel, or both, may deem, in their sole discretion, to be intoxicated, a safety risk, to have violated any venue policy or law or may bring the promotional partner into disrepute.

(n) The winner is responsible for all costs, expenses and transportation, not specifically included in the prize won in the Drawing, arising from or in connection with any prize won.

(o) Prizes are not redeemable for cash.

(p) If a date is provided for a game or event that is part of a prize described in section 3, the date is subject to change at the sole discretion of the Philadelphia Eagles.

(q) If no date is provided for a game or event that is part of a prize described in section 3, the date will be determined by the Philadelphia Eagles and will be communicated to the winner by either the Philadelphia Eagles or the Lottery.

(r) In the event the winner is not available on the date of the game or event that is part of a prize described in section 3, there will be no extensions or substitutions of prizes and the winner will not receive any reimbursement for the unused prize.

(s) In the event a prize described in section 3 is not available, the Lottery may either provide a substitute prize, determined by the Secretary to have an equivalent value to the prize won, or make a cash payment to the winner, in an amount determined by the Secretary to have an equivalent value to the prize won.

(t) The specific seats to be provided as part of any prize described in section 3 will be determined at the sole discretion of the Philadelphia Eagles.

(u) The food and beverages to be provided as part of any prize described in section 3 will be selected at the sole discretion of the Philadelphia Eagles.

(v) Each winner, their respective heirs, legal representatives, and assigns, agree to indemnify, defend, release, and discharge the Pennsylvania Lottery, Philadelphia Eagles, LLC, Eagles Stadium Operator, LLC, and the NFL, as well as their employees, officers, directors and commissioners from and against any loss, claim, damage, suit, or injury arising out of or relating to this promotion. By entering into the Drawing, the winner indemnifies, releases, discharges, and agrees to hold harmless the Pennsylvania Lottery, Philadelphia Eagles, LLC, Eagles Stadium Operator, LLC, and the NFL, as well as their employees, officers, directors and commissioners from unanticipated cancellation, suspension, or postponement of the promotion due to natural disaster, national emergency, or other unforeseen act of God or man. Winners participate solely at their own risk and responsibility.

(w) Prizes are not transferrable.

(x) Other restrictions may apply.
